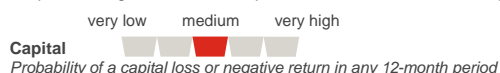

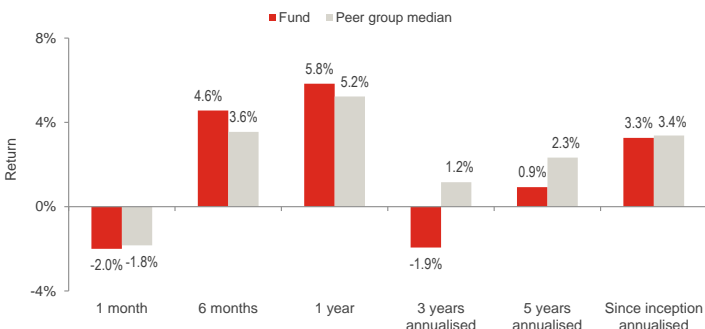

Investment objective

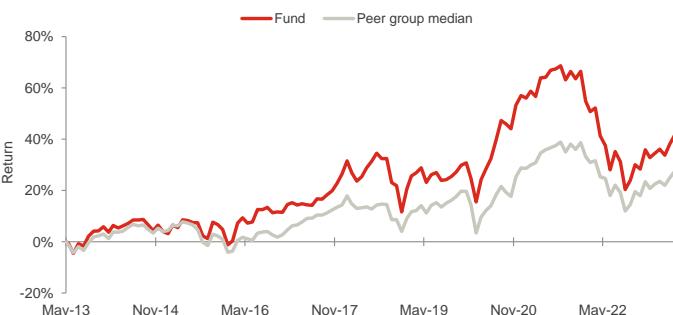
The primary objective of the Fund is capital appreciation in real terms over the investment horizon. The Fund is ideally suited to investors with a moderate to aggressive risk tolerance (measured in the base currency of the Fund) over an investment cycle of five years or longer. The diversified portfolio invests into a wide range of asset classes including cash, fixed income, equities, property and commodities. As this portfolio is global in nature, exposure will be taken in a wide range of currencies and markets.

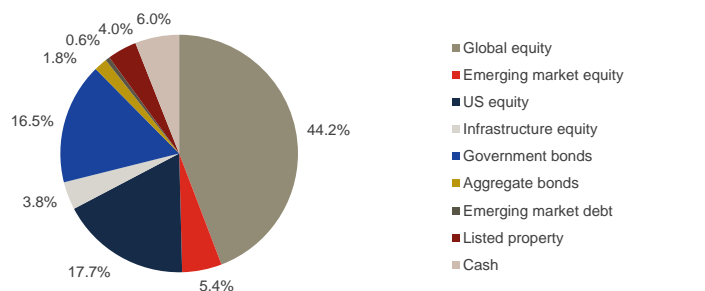

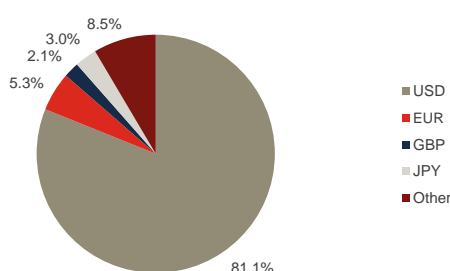

Market commentary

Market volatility increased throughout August, fueled by renewed stress around the Chinese property market, weak macroeconomic data out of China, an increase in sovereign bond yields and US Federal Reserve keeping interest rates higher for longer than expected. Major global markets recorded declines during the month with the MSCI World detracting by -2.3% MoM (+16.6% YTD). Developed markets outperformed emerging markets printing a loss of 2.3% vs 6.1%. Fixed income did not help cushion equity losses, with the Bloomberg Global Aggregate pulling back 1.4% during the month. In commodity markets, global oil prices remained flat for the month on the back of production cuts in China as growth risks keep mounting.

The S&P 500 ended the month down 1.6%.

In the UK, the blue-chip FTSE-100 ended the month down 2.5% (-0.2% YTD). Inflation cooled to a 15-month low of 6.8% y/y in July vs the 7.9% print in June on the back of lower energy prices. July core inflation excluding erratic food and energy prices remained unchanged. August saw the Bank of England (BoE) hike its policy rate by 25bps which brought the bank rate to 5.25%, with the BoE stating its intention to keep rates at restrictive levels for a while. Despite restrictive monetary policy, the UK economy surprised to the upside during the second quarter of 2023.

FTSE 100 TR finished the month down 2.5%.

In Europe, The Eurozone headline inflation remained flat in August at 5.3% y/y, defying expectations. Core inflation, however, fell from 5.5% y/y in July to 5.3% in August. While inflation is showing improvements, it remains well above the European Central Bank target (ECB) and markets continue to price in further ECB rate increases before the end of the year.

In China, economic data continued to disappoint as the second-largest economy reported weaker-than-expected July retail sales growth in August, less than expected growth in industrial data and declining manufacturing activity for a sixth straight month in August. In addition, investor sentiment was weighed down by worries over the real estate crisis as China's largest real estate giant Evergrande filed for US bankruptcy protection. A slowdown in China's economy spells trouble for the global economy, due to a significant number of companies depending on China as a revenue source.

Emerging Markets (MSCI EM 50 NR) ended the month down 6.51%.

The Caleo Global Flexible fund ended the month down 2.06%.
