



Investment objective


The primary objective of the Fund is capital appreciation in real terms over the investment horizon. The Fund is ideally suited to investors with a moderate to aggressive risk tolerance (measured in the base currency of the Fund) over an investment cycle of five years or longer. The diversified portfolio invests into a wide range of asset classes including cash, bonds, equities, property, commodities and alternative investment strategies. As this portfolio is global in nature, exposure will be taken in a wide range of currencies and markets.





Market commentary

After December saw global equity markets continue their rally, with the MSCI World index posting a further 4.2% increase for the month. This resulted in global markets being up 15.9% for 2020, rebounding by 70% off the lows reached on 23 March as the global pandemic initially took hold. This was all achieved despite expectations that global economic output will shrink by 4.4% in 2020 as well as an acceleration in global COVID-19 infections. The start of December was marked with infectious disease expert, Dr Anthony Fauci, predicting that most Americans would be vaccinated by 2Q21, leading to herd immunity by the Northern Hemisphere summer.

A \$900bn stimulus package was eventually passed by President Trump after a lot of back and forth. The package includes \$600 checks for eligible American adults and children. The US Federal Reserve pledged to continue with quantitative easing until employment and inflation were substantially higher.

Large-cap technology stocks managed to close out the year with another strong month. This would cement their position as the biggest winners in the pandemic-hit year. The NYSE FANG Index of US-listed tech heavyweights more than doubled over the year, ending 103% higher for 2020. This was largely an electric vehicle story, with Tesla and Baidu leading the charge.

The S&P 500 ended the month up 3.84%.

In Europe, 2020 was marked by the passing of a EUR750bn stimulus package that would be funded jointly through the issuance of an EU bond. With Christine Lagarde captaining the ship, the ECB's policy looks set to remain supportive. A positive side-effect to this has been to decrease the spread of peripheral bond yields relative to those of Germany, increasing the sustainability of debt loads in countries such as Spain, Italy, Portugal, and Greece. For now, the election of Joe Biden appears positive, reducing the threat of a damaging trade war with the US. These benefits, supported by an enduring trade surplus, have been supportive of the euro.

FSE DAX TR and Euronext Paris CAC 40 GR returned 3.22% and 0.76% respectively for the month while the MSCI Europe ex UK GR ended up 2.17% for the month.

In the UK, the risk of a "No Deal" outcome is now behind us, unlocking potential for global investors to return to the UK after several years of net disinvestment. The market could also be bolstered by corporate predators, which we have already started to see, notably in the bid for insurance company Royal & Sun Alliance. Banks are likely to reinstate dividends in 2021, and Energy, another large sector in this market, could benefit from the global recovery, although it will also be fighting against the tide of outflows driven by environmental concerns.

FTSE 100 TR finished the month up 3.28%.

China, the largest weight in the emerging market index, had another strong year as they were able to get the corona virus under control when compared to developed markets. China, through Alibaba and Tencent, is a world leader in mobile payments technology and usage. The world would struggle to function without Taiwan's semiconductors. Should we see a global recovery as expected in 2021, these EM giants amongst others will be well placed to benefit from a bounce in international trade. A weaker dollar would be the icing on the cake, as EM risk asset performance tends to benefit from such a trend.

Emerging markets (MSCI Emerging Markets 50 NR) ended the month 6.64% higher.

The Caleo Global Flexible fund ended up 2.47% for the month.
