Investment objective

The investment of the Fund is not constrained to an asset allocation benchmark and will be actively managed to reduce risk.

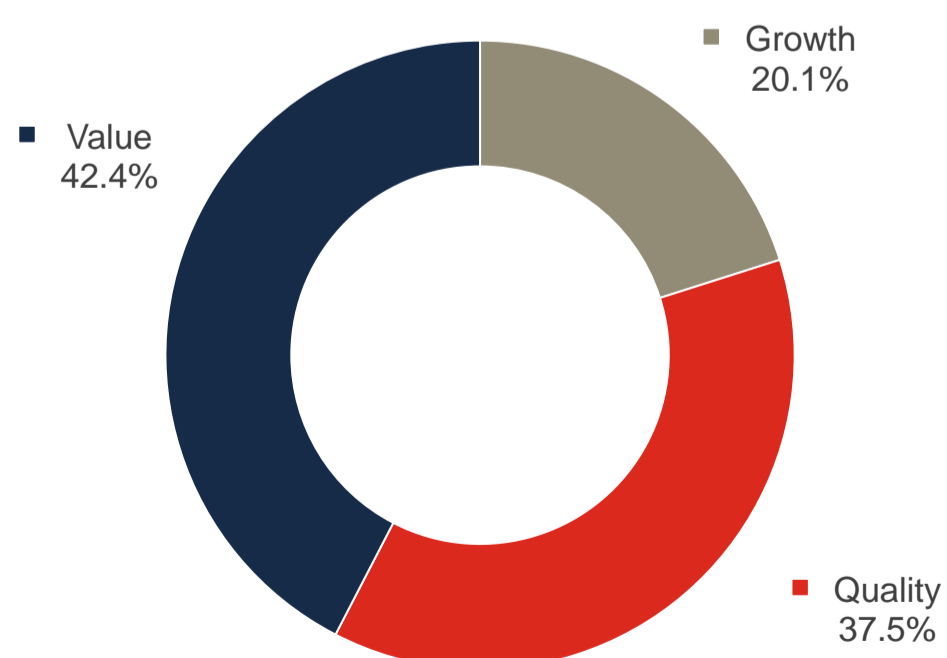

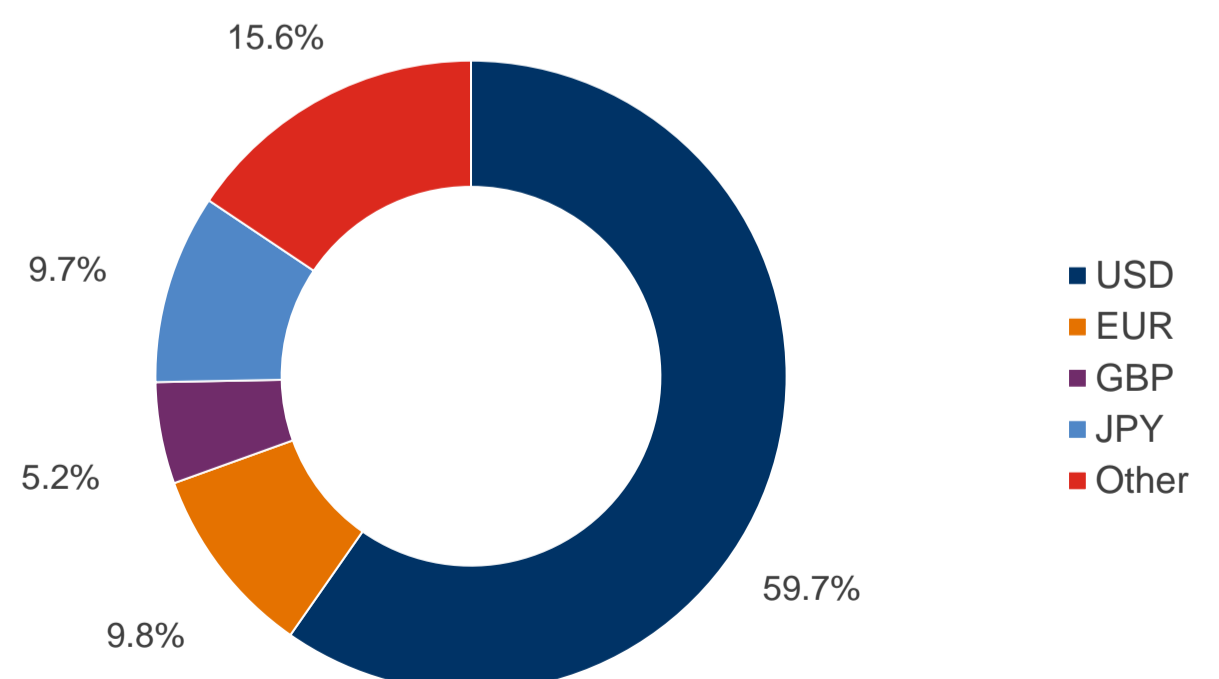
