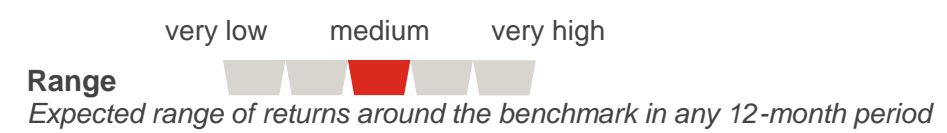
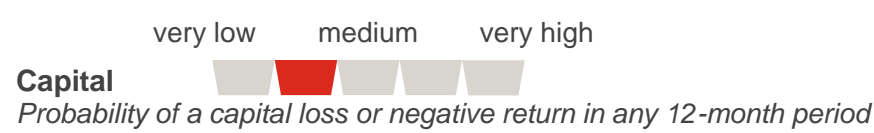

Written notice to redeem must be received by the Administrator by no later than 12:00 noon (Guernsey time) on the Business Day immediately preceding the relevant Dealing Day.

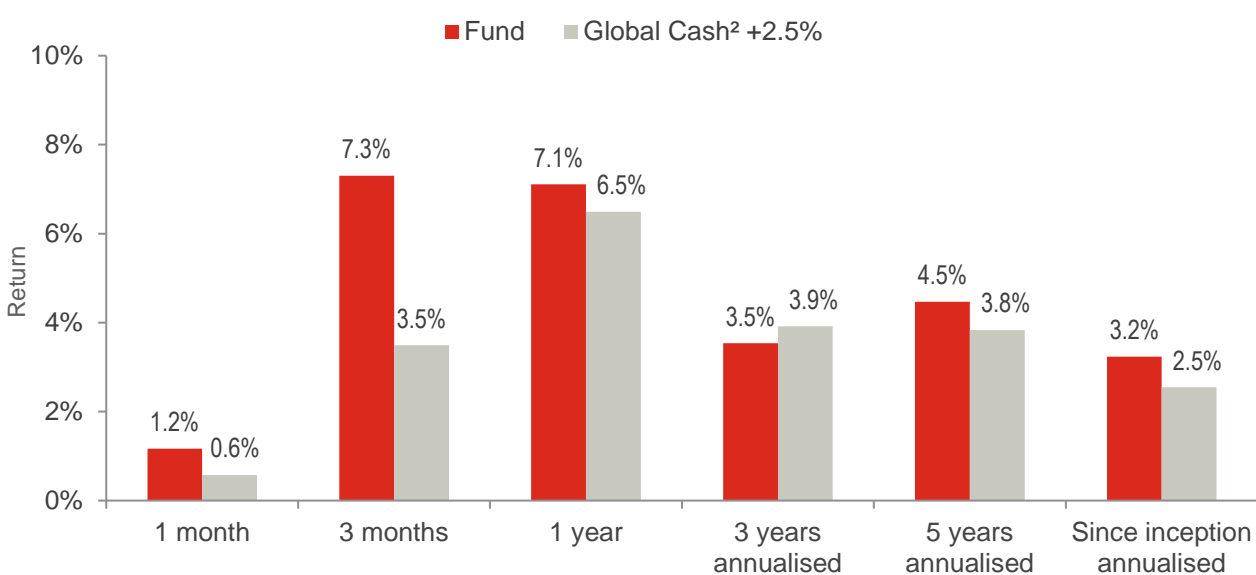

Investment objective

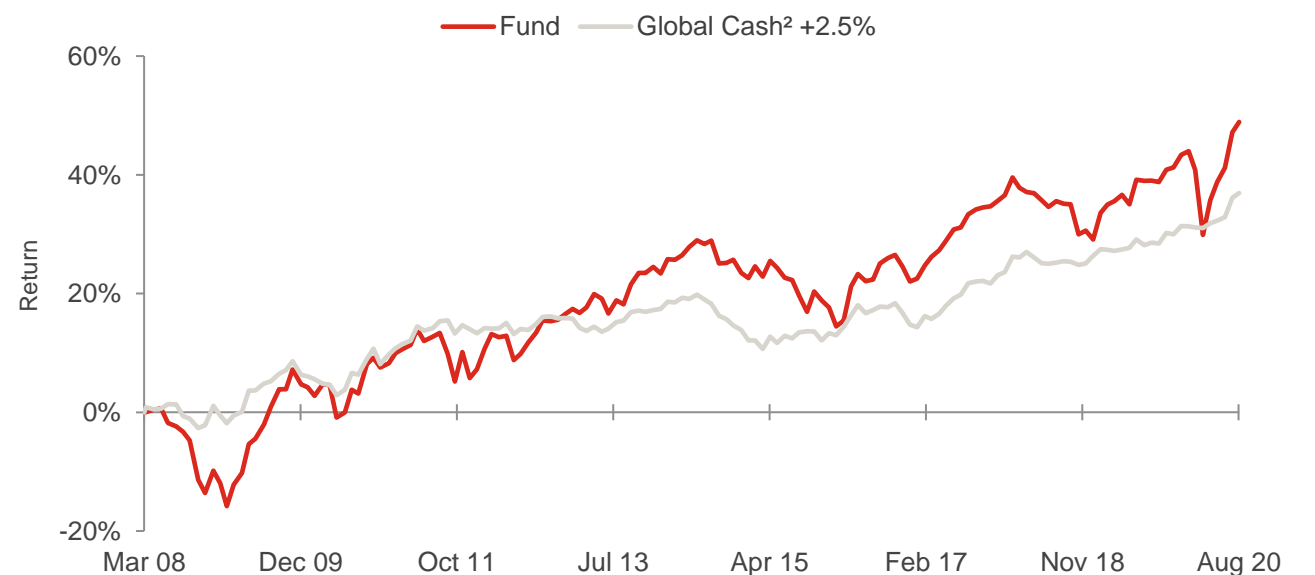
The Fund is designed to offer capital preservation with some opportunity for capital appreciation over the medium term through investment in a diversified range of international asset classes and currencies. The Fund is ideally suited to investors with a low risk tolerance with an investment horizon of 3 years or longer. The Fund intends to achieve its investment objective through a diversified global portfolio primarily consisting of investments in participatory interests of portfolios of collective investment schemes or other similar schemes.

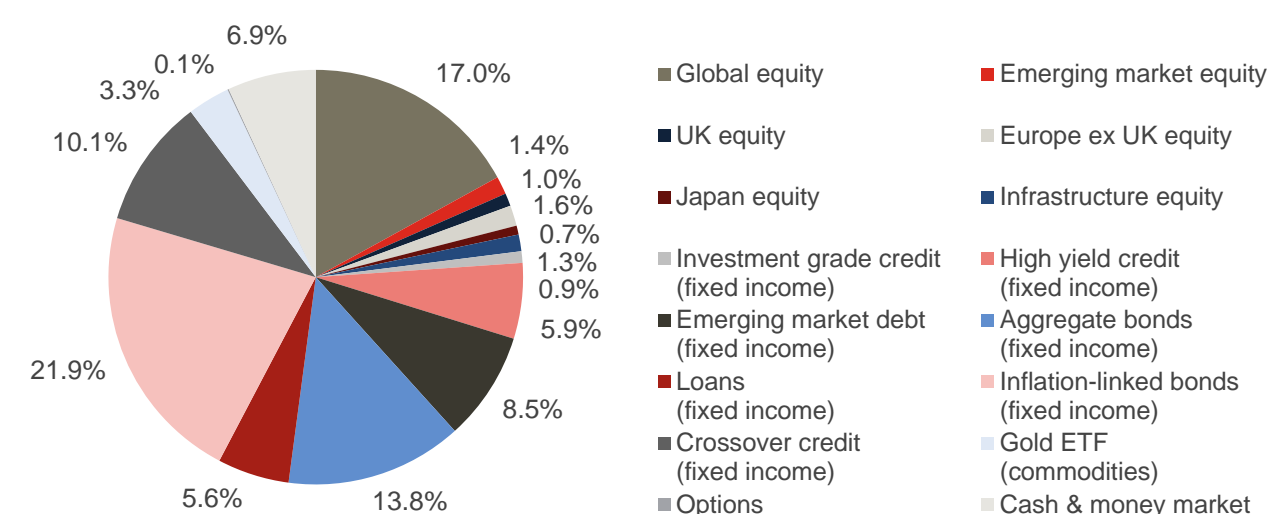

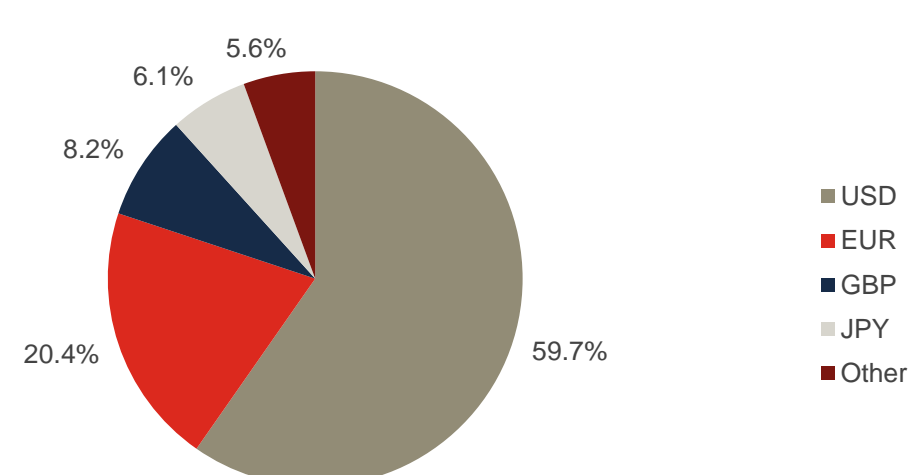

Market commentary

The pattern of market performance since the March lows continued unabated in August: global equities buoyant, led by the US and within that tech stocks; high yield bonds, emerging market debt and convertible bonds outperforming safe haven government bonds; precious metals fell slightly; and the dollar weak. The S&P 500 reached new all-time highs, dragging the MSCI World index to a new high, despite many of its other constituents remaining well below previous peaks. Global cases of Covid-19 passed 25 million and the threat of second waves in many countries is still significant. There also remains deep uncertainty about the sustainability and strength of global growth, despite the positive news flow in recent weeks. Markets are likely to continue experiencing higher levels of volatility in the months ahead, with uncertainty heightened by the US Presidential election.

Despite the recovery in leading economies to date, there remains deep uncertainty about the sustainability and strength of growth, and that uncertainty has been heightened by the possibility of second waves and/or extended first waves of Covid-19 in many countries. Encouragingly, fatalities and hospitalisations continued to decline in many regions however concerns remain, especially with the northern hemisphere winter approaching.

Emerging markets returned 2.2% in August in dollar terms. Meanwhile developed markets, measured by the MSCI World index, returned 6.7%, led by the US and Japan, with gains of 7.1% and 8.2% respectively.

Bond markets fell overall in August, with US investment grade corporate bonds returning -1.4% compared with -1.2% from Treasuries, while high yield bonds returned 1.0%.

2021 promises to be a year of robust recovery in economies and corporate earnings, and risk assets will have continuing strong support from ultra-loose monetary policy for years ahead. Furthermore, markets are not discounting the early roll-out of a vaccine; any good news on this front would be a major boost to confidence and sentiment and might well herald a period of significant outperformance by value stocks over growth. We therefore expect markets to move higher through 2021 and would use setbacks in the months ahead as a buying opportunity.
